## Major City Construction Projects – Summer 2011

### 24th Street Overlay and 1st Ave N Overlay

The City will be resurfacing 24th Street West from Grand Avenue to Central Avenue, Grand Avenue from 24th Street West to the BBWA Canal, and 1st Avenue North from North 18th Street to North 30th Street. This work is anticipated to start in June and last approximately four weeks.

Most of the work will be done at night between the hours of 10 p.m. and 6 a.m. There will be temporary single-lane closures during the day to remove and replace manholes in preparation of the resurfacing.

### Water Replacement Project

The Public Works Department is planning another season of water improvement projects, so commuters should be aware of several areas around Billings where major construction will be taking place between May and October. The major water main replacement project will occur on 4th Avenue North between North 18th and North 28th Streets. Other water main replacement projects will occur on North 33rd, 34th and 35th Streets between Montana Avenue and Division Street, as well as on 1st and 2nd Avenue North between North 33rd and

Division Streets. Commuters should expect reduced driving speeds, travel lane restrictions, detours and road closures in these project areas.

### Rimrock Road

The Rimrock Road reconstruction project will improve Rimrock Road from 17th Street West to Forsythia Boulevard. Improvements generally consist of street widening, installation of curb/gutter, sidewalk, drive approaches, streetlights, and replacement of the water main. Drivers within the project limits (inclusive of garbage, mail, and bus service) will continue to have access to individual homes; however, as the construction project pro-

gresses along the length of Rimrock, drivers may need to alter their typical routes to access their homes. The project will be closed to through traffic, and those drivers will be asked to stay on the main streets of Rehberg, Poly, and 17th. The project is scheduled to begin in late May or early June and last through September.

## Parks Department Receives a New Trash Truck

The Parks Department recently took delivery of a new trash truck. A grant from Exxon Mobil funded 100 percent

of the cost of the truck. The new trash truck will greatly improve the effectiveness and efficiency of trash removal from all City parks.



## Recycling Bleachers from Cobb Field

A recycling program is under way in the City of Billings' Park Maintenance shop. Aluminum seating from the former Cobb Field Stadium is now being retrofitted for picnic table seats and

tops. Approximately 100 tables have been refurbished so far, at a retail value of \$250 each, while eliminating the need for future wood, paint and labor costs. The tables are being placed throughout the entire City Park System.



## Swords Park Phase II Trail Development

PRPL has retained Sanderson Stewart of Billings to do consulting work

for the second phase of trail development at Swords Park. This new section will connect the existing two mile segment along the Rims (beginning at the "roundabout" on 27th Street and ending near the electrical substation) with the tunnel and trail segment that was recently completed as part of the Airport Road Improvement Project at the intersection of Airport Road and Aronson Avenue. Design work has begun in earnest and PRPL is currently reviewing alternative trail alignments. It is anticipated that this project will go out for bid this spring and be constructed this summer. Completion of the project is scheduled for October of this year.

# Planning Continues for New Downtown Library

Over most of last summer, a committee including representatives from throughout the community identified the block on which Parmly Billings Library currently is located as the preferred site for a remodeled or new library building.

The committee's recommendation was validated by a phone and online survey of nearly 400 residents, who matched the demographic makeup of Billings for geographic location within the city, age, education, and other dimensions.

In the fall, the Parmly Billings Library Foundation identified a donor, who currently wishes to remain anonymous, willing to commit \$2 million for the design and construction of a new building of architectural significance.

Also during the fall, the opportunity arose for the City to attempt to acquire, through land exchanges, the former Underriner Motors property that makes up the preferred site; negotiations are in process. As 2010 drew to a close, the Library Board

of Trustees recommended to the City Council that the donor's gift and condition be accepted and a new building be planned to be built on the same block that the current building stands on, and the City Council approved the recommendation.

In January, the donor selected Will Bruder + Partners of Phoenix, AZ, as the design architects for the project and they have subsequently partnered with local firm O2 Architects. On Feb. 1, about 200 people participated in two public input sessions facilitated by Will Bruder with assistance from 11 students from the Community Design Center at Montana State University School of Architecture. Six focus groups provided additional input in person, and hundreds more have completed suggestion forms at the Library or online in the weeks since.

Schematic design plans and renderings are expected to be available this spring, with many opportunities for public feedback to be provided.

The Library Foundation continues with plans to achieve its goal of raising a total of \$5 million privately. The balance of the project would be paid for through general obligation bonds that Billings residents would vote on this November. The \$13.4 million amount of bonds for a library project in the Capital Improvement Plan is the estimated cost of repairing the current building's first through third floors.

The Library Board encourages all residents of the community to stay informed about the planning process for a new downtown building. # Airport Tri-Annual Emergency Drill

On May 18, the City of Billings Logan International Airport will conduct a drill that will simulate an aircraft-related emergency at the Airport.

Certificated airports across the nation are required

by the Federal Aviation Administration to test their Airport Emergency Plan every three years with a live drill, utilizing props and actors, to simulate an airport emergency of some kind.

This type of drill requires numerous hours of planning, setting the stage for an emergency response from the Airport's Aircraft Rescue Fire Fighting team, and from participating agencies such as the Billings Fire Department, American Medical Response, local hospitals, Federal, State, and Local Law Enforcement, the Department of Emergency

Services, local volunteer and citizens organizations, local schools, and the local refineries.

Upon completion of the drill, feedback is provided to Airport officials and used to enhance the Airport's Emergency Response Plan.

While no community would ever want to experience a large scale emergency, accident, or disaster that these types of drills simulate, the City of Billings Logan International Airport and the local emergency response community is committed to being prepared, just in case.

## Nonresident Travelers to Billings in 2010

Montana remains a popular visitor destination. Billings Logan International Airport participates in a program conducted by the University of Montana's Institute for Tourism and Recreation Research (ITRR) to survey arriving passengers. The ITRR collects visitor data such as where they reside, how long they plan to stay, whether they have visited Billings before, the size of their travel group and the reason for their trip to Billings.

The ITRR recently released the following survey results for 2010. The Billings Airport serves as one of the main entry points for visitors to Montana. The average length of stay was 5.14 nights.

About 77 percent of the visitors

were repeat visitors to Billings, with the first and fourth quarters having 82 percent repeat visitors. Most of the travelers arrived either solo or in a group of two. Most visitors came here primarily for business reasons, while in 2009, about 30 percent arrived for business or to attend a convention. The fourth quarter had the highest percentage of business travelers at 52 percent. On average, about 18 percent came here primarily for vacation. The third quarter showed the highest percentage of vacation-related travel at 32 percent, just under the 33 percent who came here for business. The chart to the right shows where the largest percentage of surveyed visitors resided.

# June Hazardous Waste Collection Events

On Friday, June 3, the Billings Solid Waste Division will sponsor a hazardous waste collection event for small businesses.

To qualify, businesses must not produce more than 220 pounds of hazardous waste per month, nor have accumulated more than 2,200 pounds of hazardous waste for disposal. Participants must be pre-approved and regis-

ter for an appointment by calling (406) 247-8633.

On Saturday, June 4, the City of Billings will sponsor its 17th annual Toxic Trash Round-Up, a household hazardous waste collection event for residents of Yellowstone, Treasure, Musselshell, Carbon and Stillwater counties.

Residents may bring their unwanted, unused and leftover household chemi-

cals to the Billings Operation Center, 4848 Midland Road, between 9 a.m. and 4 p.m. Items that will be accepted include medications, ammunition, paint, used oil, fluorescent bulbs, batteries and garden chemicals.

Items not accepted include medical waste, agricultural chemicals, explosives and electronic waste. For more information, call (406) 247-8633.



## Q & A From our Readers

### Questions and comments from Trevor Krieger of Billings:

Greetings. I have a question and comments regarding the response in the last CityLink to a question about warrants for turning arrows at intersection traffic lights. The response said that turn arrows are based on the volume of traffic. Who takes the census on each of the busy intersections to warrant the turn signal? I would encourage them to motor up to the Heights and take a look at every major intersection from Lake Elmo and move north. There should be adequate timing for everyone turning at each of those major intersections. The history of automobile crashes (including some deaths) at each (Lake Elmo/Main; Hilltop/Main; etc) should be warrant enough. It is quite ridiculous to wait and then try and turn on a yellow light (or claim the intersection, and just have enough time for one person to turn as the light turns red) ... not safe at all. As an emergency vehicle operator, I have seen it up close and personal. The effects are only going to get worse as the traffic and population volumes of Billings' Heights grows and grows. Please ... take some time to warrant turn lights in the heights. Granted, there are a

couple of exceptions, but all should be reevaluated. Thanks.

### Answer:

Main Street is a Montana Department of Transportation (MDT) operated corridor so any warrant studies or signal modifications would be done by MDT. MDT has recently undertaken a warrant study at Hilltop and Main but the results are not finalized yet. Warrant studies are planned along Main Street at other locations but will not be conducted until after the 6th Avenue and Bench Connection project is completed later this year. With the construction of Airport Road, Aronson Avenue, and the Bench bridge, the traffic patterns on Main Street are anticipated to change and in order to capture the most relevant information, the studies will need to be done after that work is completed. As discussed in the article you refer to though, please remember that any additional time given to protected left turns takes away from "green" time on Main Street.

### Comments from Beverly Smith of Billings:

I like the "Construction in the City" and the "Holiday and Winter

Fire Safety" articles. I've enjoyed the CityLink since its beginning. I would like to see more on the Metra and continued updates on construction.

### Answer:

Thank you for the compliments and for being an avid reader. CityLink staff thought this might be a great time to reiterate what may be addressed in this publication. The City is responsible for many departments, but cannot provide answers to questions that pertain to County, State or Federal Agencies. The City also cannot address questions regarding the school district and their policies. As MetraPark is a Yellowstone County facility, CityLink staff will not be providing updates on its progress. However, local media has been periodically updating their audiences about MetraPark construction and the MetraPark website contains a link to view arena progress at <http://metrapark.wordpress.com>.

### Question from an anonymous Billings reader:

How has the ban on cell phones while driving working? How many warning and tickets have been issued? When the ordinance first went into effect, I noticed a real drop off

in the number of people I saw on cell phones. But recently, I'm seeing more. Just curious.

### Answer:

The intent of the cell phone usage ban was to reduce distracted driving accidents. In the past and currently there has been no tracking mechanism on the State Accident form to distinguish between different distracted driving accidents. So, we do not know if accident rates have been reduced since the cell phone usage ban while driving went into effect in Billings. Since the cell phone usage ban, we have had one citation issued for cell phone usage associated with an accident. Officers have seen a decrease in people using cell phones while driving. There have been 95 warnings and 15 citations issued. Education and continuing to keep people aware of the cell phone usage ban is critical. In the initial phase, there was a great deal of media coverage on the cell phone ban. The Billings Police Department plans to continue issuing public service announcements to remind drivers of the ban.

# Simulations: The Future of Fire Service Training

The Billings Fire Department has found that computer-based simulation training provides a unique opportunity to practice firefighting year-round in a controlled environment.

A key component of training in the fire service is the ability to repeat and practice skills until they become second

nature. This type of training enhances the decision-making process, as well as every skill needed on all types of emergencies.

The Billings Fire Department, in cooperation with area fire departments, local refineries, Riverstone Health, Yellowstone County and the College of Technology, implemented

a computer-based software "Incident Command" training lab. The simulator allows the training instructor to incorporate up to 200 different fire scenarios in single and multi-family residential properties. Firefighting priorities used on most residential fires can be easily repeated in this virtual 3D environment.

Through the simulation process, the Incident Commander has the responsibility to match specific crews to essential tasks while tracking their progress. The simulator is interactive and supports decision-making, such as which crew should be assigned to put the fire out, who looks for victims, and how the heat and smoke can be

ventilated from the structure.

The repetitive training supports basic and advanced skills and helps firefighters understand the importance of working together to accomplish a common goal. An essential priority of simulation training is that firefighter and citizen safety is incorporated into every practice session.

Simulation training will not replace hands-on training; however, it can better prepare firefighters for the next structure fire. The ability to use simulations to enhance crew skills, improve performance, and develop decision-making abilities has a proven track record. Although simulator training does not take the place of hands-on training, it does enhance the overall goal to practice real-life situations.



## VITA Free Tax Preparation Sites Expand in 2011

Tax filers with basic returns who made \$49,000 or less in 2010 can have their taxes prepared and e-filed free by IRS-certified volunteers at seven Billings VITA locations. VITA (Volunteer Income Tax Assistance) sites specialize in helping people who make less than \$49,000 get all the tax benefits they qualify for. In addition, taxpayers 60 years of age and older may have their taxes prepared free at the AARP/TCE site located at the Yellowstone County Council on Aging.

Last year, Billings VITA sites helped clients claim approximately \$2 million in tax refunds and save an estimated \$333,000 in preparation and potential loan fees.

This year VITA volunteers will be preparing returns at seven locations. In Billings, HRDC7, Parmly Billings Library, Garfield Community Resource Center, Altana Federal Credit Union, Billings Federal Credit Union, and

Rimrock Credit Union will host VITA sites. In Laurel, SEG Federal Credit Union will host a VITA site.
