RESOLUTION NO. 07-18580

A RESOLUTION OF INTENTION TO CREATE SPECIAL IMPROVEMENT LIGHTING MAINTENANCE DISTRICT NO. 301 OF THE CITY OF BILLINGS, MONTANA, FOR THE PURPOSE OF PROVIDING ENERGY AND MAINTENANCE FOR STREET LIGHTS, DESIGNATING THE NUMBER OF SAID DISTRICT, DESCRIBING THE BOUNDARIES THEREOF, STATING THE GENERAL CHARACTER OF THE IMPROVEMENTS TO BE MADE, ESTABLISHING THE ESTIMATE OF THE COST OF MAINTAINING SUCH LIGHTS AND SUPPLYING ELECTRICAL CURRENT THEREFOR FOR THE FIRST YEAR, THE PROPORTION OF THE COST TO BE ASSESSED AGAINST THE ABUTTING PROPERTY, AND THE METHOD OF ASSESSMENT OF SAID COST.

WHEREAS, the City Council of Billings, Montana, has determined that the public interest ar convenience require the creation of a Special Improvement Lighting Maintenance District as hereinaft provided;

NOW THEREFORE, BE IT RESOLVED BY THE CITY COUNCIL OF THE CITY OF BILLING MONTANA:

SECTION 1:

That the public interest and convenience require, and it is deemed necessary, to create a Speci Improvement Lighting Maintenance District for the purpose providing energy and maintenance for new stre lights for lighting in said district; and the intention of said City Council to create such a district, hereinaft more particularly described, is hereby declared.

SECTION 2:

That said district shall be known and designated as "Special Improvement Lighting Maintenand District No. 301" hereinafter called the District, and the boundaries of the District are hereby declared include: All lots, parcels and pieces of land within Phase I of Josephine Crossing Subdivision, as shown on the map designated as Exhibit "A" attached hereto, and as listed in Exhibit "B" which is attached hereto. The district boundary shall be as described in Exhibit "C" attached hereto.

SECTION 3:

That the City of Billings, Montana, hereby finds, determines and declares that each of the lots, block pieces and parcels of land situated within the boundaries of the District, will be especially benefited at affected by said improvements, and that all of the property included within the District is hereby declared to I the property to be assessed for the cost and expense of obtaining the electrical energy for and maintenance said street lights.

SECTION 4:

That the general character of the improvements to be made for the District is hereby declared to be follows: The provision of energy and maintenance for street lighting facilities consisting of fifty (50) 100-was high-pressure sodium, pendant cone style, black luminaire fixtures mounted on decorative round taper fiberglass poles and served by underground wiring, with one pole being a double mounted light NorthWestern Energy shall own and install the streetlights and all associated appurtenant structures as materials.

SECTION 5:

The City of Billings intends to establish the approximate contract rate for installation & operation this lighting as follows: \$3.62 per 100 watt unit, per month for supplying electrical energy; \$1.20 per unit, per month for maintenance; and \$26.59 per unit, per month for installation and ownership costs. These rates accordance with the applicable rate schedules approved by the Montana Public Service Commissic NorthWestern Energy Company shall provide energy to all of the lights and shall at all times own the lig fixtures, poles, cables, and other incidental equipment, and shall provide maintenance and repairs to sa equipment as part of the monthly rate for these lights.

SECTION 6:

The estimate of the cost of the District per year, including City administrative costs, is the sum of \$23,252.97; that the entire cost of said District shall be paid by the owners of the property within said District, with each lot, parcel or piece of land within the District to be assessed for that portion of the whole cost which it's assessable area bears to the assessable area of the entire District, exclusive of streets, avenues, alleys and public places. The estimated cost of the District per year for property owners is on the basis of approximately \$0.03684357 per square foot of assessable area. Due to the difference in the time the lighting service started and the time assessments can be levied, the first assessment will cover a period of operation of the District greater than one year and is estimated to total \$29,548.45 or approximately \$0.04681854 per square foot.

SECTION 7:

That the entire cost of the District shall be paid by an annual assessment against the property in the District; that annually, pursuant to MCA 7-12-4332, the City Council shall adopt a resolution estimating the cost of maintaining said lights including a reserve, and furnishing electrical current and assessing all of said property within said District for the annual costs; that all monies derived from the collection of such assessments shall be paid into a fund to be known as "Special Lighting Maintenance District No. 301 Maintenance Fund," and warrants shall be drawn on said fund for the payment of such costs of maintaining such lights and supplying electrical current therefore.

SECTION 8:

That on the 13th day of August, 2007, at 6:30 o'clock p.m., at the Council Chambers of the City Hall ir said City, the City Council intends to create such Special Improvement Lighting Maintenance District No. 301 and will hear objections and protests against the proposed improvements and the extent and creation of such District to be assessed, or any matter pertaining thereto, at said time and place, by any person, firm, or corporation who has filed a written protest with the City Clerk of the City of Billings within fifteen (15) days after the date on which the Notice of the passage of this Resolution of Intention is mailed to the property owners affected and published in "The Billings Times".

SECTION 9:

That the City Clerk is hereby authorized and directed to publish a copy of the Notice of the passage of this Resolution in "The Billings Times", a weekly newspaper published and circulated in the City of Billings Montana, and to send a copy of said Notice to the owners of all the lots, blocks, pieces or parcels of land included within the boundaries of said Special Improvement Lighting Maintenance District No. 301. Said notice is to be published and mailed on the same date.
