

RESOLUTION 14-10340

A RESOLUTION TO MAKE **FISCAL YEAR 2013/2014** ADJUSTMENTS TO APPROPRIATIONS PURSUANT TO M.C.A. 7-6-4006 AS AMENDED, AND PROVIDING TRANSFERS AND REVISIONS WITHIN THE GENERAL CLASS OF SALARIES AND WAGES, MAINTENANCE AND SUPPORT AND CAPITAL OUTLAY.

**Fund 0100 - General Fund, Parks, Recreation and Public Lands Department; Fund 8730 - Park Maintenance District 1 Fund**



The Parks, Recreation and Public Lands department is looking to increase hourly wage rates for summer seasonal employees to be competitive in the local economy and with other similar service providers in Billings. The concern is that the City will not be able to attract enough applicants this summer to offer the level of services and parks maintenance our community is accustomed. The positions included with this amendment are for Parks, Aquatic, Forestry and Cemetery seasonal staff. Without enough seasonal staff the City will have to consider reduced pool hours or facility closures, park restroom closures, less frequent irrigating and mowing, etc. Reserves will be used to pay for the increases.
