

RESOLUTION NO. 97- 17199

A RESOLUTION OF THE CITY OF BILLINGS ESTABLISHING NEW FEES TO BE CHARGED BY THE CITY FOR SERVICES PROVIDED BY THE PARKS, RECREATION, CEMETERY AND PUBLIC LANDS DEPARTMENT IN THE RECREATION DIVISION, ESTABLISHING AN EFFECTIVE DATE **AND AMENDING RESOLUTION 97-17192.**

WHEREAS, The City of Billings provides certain services to the public in the Recreation Division through the Department of Parks, Recreation, Cemetery and Public Lands; and

WHEREAS, it is in the best interest of the citizens of the City that the City provide said services and that the City Council establish new fee schedules for said services; and

WHEREAS, the City Council considered the proposal to raise aquatic fees at their February 10, 1997 meeting, and subsequently approved Resolution 97-17192 approving the increase of aquatic fees;

WHEREAS, the City Council having duly reconsidered the matter, now wishes to retain the previous fee schedule, in effect prior to the passage of Resolution 97-17192;

NOW THEREFORE, BE IT RESOLVED BY THE CITY COUNCIL OF THE CITY OF BILLINGS, MONTANA, AS FOLLOWS:

1. Fees for Recreation Division Services. The new fees to be charged by the City for recreation division services provided by the Department of Parks, Recreation, Cemetery and Public Lands through its Recreation Division, are hereby established as set forth in the attached exhibit, EXHIBIT "A" attached and made a part hereof.
2. Term of Fees. Said fees shall continue in full force and effect until changed by the City Council by subsequent resolution.
3. Repealer of Previous Fee. Any fees previously established which are inconsistent herewith are hereby repealed.

GOLD PASS - Good at all city aquatic facilities

Family (up to six members) \$45.00
Individual Adult (18 and up) \$30.00
Individual Youth (7-17) \$20.00

SILVER PASS - Good for one specified aquatic facility

Family (up to six members) \$40.00
Individual Adult (18 and up) \$25.00
Individual Youth (7-17) \$15.00

Season passes are non-refundable and a 10% discount will be given if purchased before June 4th at the Recreation Office.
