About this Report

As part of its participation in The National Citizen Survey™, the City of Billings conducted a mailed survey of 1,400 residents. Surveys were mailed to randomly selected households in May 2016 and data was collected through July 2016. Two weeks before the official data collection period was over and the data was reported (see the report, The National Citizen Survey: Community Livability Report, Billings, MT 2016), the City made available a web-based survey to its residents through a link on the City's website. Visitors to the site were able to complete the survey during July 2016 and 1,249 surveys were received.

This report contains the results of this administration of the web-based survey and have not been weighted to current population estimates of Billings.
