




Limits of Annexation Map



Arrests by Race/Ethnicity*



Office of Professional Standards



Annual Statistical Report

January 1, 2013 – December 31, 2013

Introduction

The Office of Professional Standards is directed by a police captain who reports directly to the Chief of Police and Deputy Chief. The primary function of this office is the receipt, assignment and investigation of complaints received from citizens or initiated by the department regarding the actions of employees. This office monitors all investigations for timely completion and reports the findings to the complaining parties and subject employee(s).

Other functions include tracking of citizen commendations of employees, use of force, pursuits, and assigning staff for follow-up when required. The Office of Professional Standards also manages and tracks the Department's discipline process.

For purposes of this report, the term 'employee' denotes both sworn (officer) and non-sworn (civilian) members of the Billings Police Department.

Complaints

A *complaint* is an incident which gives rise to one or more allegations of misconduct. A single complaint may allege misconduct by multiple employees and/or multiple violations of departmental policies. The number of complaints filed may not equal the number of allegations and findings resulting from the investigation.

Citizen Complaints and Inquiries

Citizen complaints are classified in one of two categories. Class II complaints include allegations of inadequate service, discourtesy, minor performance issues, improper procedure and other less serious and non-criminal conduct. Class I complaints are more serious and include allegations such as excessive force, violations of criminal law, breach of civil rights, bias policing, patterns of similar Class II complaints and other more serious allegations.

Department Initiated Complaints

If a complaint is initiated by a BPD supervisor or brought to supervisory attention by any BPD employee, it is classified as a department initiated complaint.

Allegations and Findings

Allegations represent a distinctly different category than complaints. They are assertions of an employee's behavior that, if proven, would amount to a violation of department policy. A single complaint may result in multiple allegations of misconduct against one employee, single allegations against multiple employees, or any combination thereof.

Findings are issued for each allegation in an investigation, including those made by the complainant as well as any allegations of misconduct not included in the original complaint, but that may be discovered during the investigation. Findings are also issued when policy violations are discovered during a review of employee performance following an incident such as a pursuit, a use of force or an employee vehicular accident. For these reasons, the number of findings issued will exceed the number of complaints reported.

Although complaints are the primary basis for our statistical reporting, we also track the findings for each allegation, rather than a single overall finding for each individual complaint. Examining allegations separately from complaints is useful in gaining a more accurate understanding of areas of concern to citizens and to the department.

Findings fall into one of four categories. The following table represents the findings issued for 2013 cases.

PROPER CONDUCT/TRAINING DEFICIENCY/POLICY FAILURE (Exonerated) – The acts, which provided the basis for the complaint or allegation did occur, but were justified, lawful and proper. This finding also may be used when the acts complained of did occur and were not proper or justified, but resulted from a lack of policy or training.

IMPROPER CONDUCT (Sustained) – The investigation disclosed sufficient evidence to clearly prove the allegations(s) made.

INSUFFICIENT EVIDENCE (Not Sustained) – The investigation failed to discover sufficient evidence to clearly prove or disprove the allegations made.

UNFOUNDED – The investigation conclusively proved that the act or acts complained of did not occur. This finding also applies when individual officer(s) or employee(s) named were not involved in the act or in acts, which may have occurred.

RESOLVED W/ COMPLAINANT – This only applies to Class II Complaints. The determination of guilt may not be clear (Sustained or Not Sustained) whereas the complainant is satisfied with results of investigation.

PENDING – The investigation is still on-going and the findings have not yet been determined.



The Internet Crimes Against Children Task Force program is a **nationwide initiative** started in 1998 under the U.S. Department of


Justice Office of Juvenile Justice Delinquency Prevention. By 2007, **every state** in the union had a funded ICAC task force program.

ANIMAL CONTROL BOARD

Due to vacancies on the Animal Control Board no Board meetings were held in 2013.

In December of 2013, City of Billings Mayor Tom Hanel approved the appointment of (2) two new members to the Animal Control Board. A Board meeting is anticipated to take place in February of 2014.

FACILITY

Original plans for the construction of the Animal Shelter failed to consider air-conditioning for areas of the Shelter where animals would be housed. Continued adjustments to the air-flow resulted in the unit being unable to provide adequate comfort for any of the areas within the facility. In 2013 a second unit was purchased and installed. With the installation of the second unit, and re-adjustments, all areas of the facility can now be made comfortable during the hot summer months for the staff, citizens visiting the facility, and the animals.

A major software meltdown in 2012 caused the loss of animal records within the computer system. Due to staffing limitations and amount of information requiring re-entry, 2012 statistics are still unavailable.

ENFORCEMENT

In 2013 - 64% of the officers’ total time worked was spent in the field, 22% writing reports, 8% preparing for the field and training, 3% on kennel duties, and 3% assisting or working in the Animal Control Office. Animal Control Officers traveled 47,007 miles on the City streets enforcing animal control laws.



On September 10, 2012, City Council approved the ordinance allowing for residents to have up to six (6) chickens (hens) on their property. In order to do so citizens would be required to purchase a Permit and also follow some minimum guidelines. As of January 1, 2014, a total of 52 Permits had been sold. Concerns originally raised about allowing such a practice have not surfaced. Officers during the year of 2013 received and responded to approximately 10 chicken-related complaints.
