

ORDINANCE NO. 98- 5071

AN ORDINANCE AMENDING THE ZONE CLASSIFICATION ON THE WEST 120.6 FEET OF LOTS 3, 4 AND 8 OF PEMBERTON SUBDIVISION AND THE EAST 60.3 FEET OF LOT 8 AND FRACTIONS OF LOTS 3, 4 AND 7 OF PEMBERTON SUBDIVISION THAT ARE LOCATED NORTHWEST OF MAIN STREET (AT 636 PEMBERTON LANE AND 2318 MAIN STREET).

BE IT ORDAINED BY THE CITY COUNCIL OF THE CITY OF BILLINGS, MONTANA:

1. RECITALS. Whereas, M.C.A. 76-2-304 and the City Zoning Ordinance No. 3797, as amended by Ordinance No. 4102, Section 7.01, provide for amendment to the City Zoning Map from time to time. the City Zoning Commission and staff have reviewed the proposed zoning for the real property hereinafter described. The Staff and Zoning Commission have considered the twelve (12) criteria required by M.C.A., Title 76, Chapter 2, Part 3. The recommendations of the Staff and Zoning Commission have been submitted to the City Council and the City Council, in due deliberation, has considered the twelve (12) criteria required by State Law.

2. DESCRIPTION. That the **West 120.6 feet of Lots 3, 4 and 8 of Pemberton Subdivision and the east 60.3 feet of Lot 8 and fractions of Lots 3, 4 and 7 of Pemberton Subdivision that are located northwest of Main Street (at 636 Pemberton Lane and 2318 Main Street)** is/are presently zoned **Residential Manufactured Home** and is shown on the official zoning map within this zone.

3. ZONE AMENDMENT. That Ordinance No. 3797, as amended by Ordinance No. 4102, and the official zoning map are hereby amended and the zoning for the **West 120.6 feet of Lots 3, 4 and 8 of Pemberton Subdivision and the east 60.3 feet of Lot 8 and fractions of Lots 3, 4 and 7 of Pemberton Subdivision that are located northwest of Main Street (at 636 Pemberton Lane and 2318 Main Street)** is/are hereby changed from **Residential Manufactured Home** to **Highway Commercial** and from the effective date of this ordinance, shall be subject to all the rules and regulations pertaining to **Highway Commercial** as defined in the Zoning Ordinance and Billings Montana City Code (BMCC).

4. REPEALER. That all ordinances or parts of ordinances in conflict herewith are hereby repealed.

5. EFFECTIVE DATE. That this ordinance shall be effective from and after final passage and as provided by law.
