## **RESOLUTION 21-10927**

## A RESOLUTION LEVYING A SPECIAL TAX UPON PROPERTY WITHIN THE CITY OF BILLINGS, MONTANA, TO DEFRAY THE COST OF CUTTING AND/OR EXTERMINATING WEEDS.

WHEREAS, Billings, Montana City Code, Section 25-307, provides that the City Clerk shall prepare and present a resolution containing a list of all parcels of land in the City, from which and adjacent to which, the weeds were cut, exterminated and/or removed, and such list shall contain opposite the number of such lots or description of such parcels of land, the name of the owner, if known, and the amount of cost for cutting and removing such weeds.

NOW, THEREFORE, BE IT RESOLVED BY THE CITY COUNCIL OF THE CITY OF BILLINGS, MONTANA, AS FOLLOWS:

- 1. <u>LEVYING OF SPECIAL ASSESSMENT.</u> That for the purpose of collecting funds to defray the cost of cutting and removing of weeds, there is hereby levied an assessment upon the owners and the lots or parcels described on the list attached hereto.
- 2. <u>ASSESSMENT AND COLLECTION.</u> Said assessment shall be placed upon the assessment rolls and collected in the same manner as other assessments.
- 3. <u>DISPOSITION OF COLLECTIONS.</u> All monies collected from the assessment shall be paid to the General Fund of the City of Billings.

- 4. <u>NOTICE OF HEARING.</u> On **Monday, February 22<sup>nd</sup>, 2021,** at 5:30 p.m., or as soon thereafter as the matter was considered on the agenda. The City Clerk is hereby directed to publish notice thereof twice, at least five (5) days prior to the hearing, in the <u>Yellowstone County News.</u>
  - EFFECTIVE DATE. This resolution shall be effective upon adoption.
