

ORDINANCE 22-5804

AN ORDINANCE OF THE CITY OF BILLINGS, PROVIDING THAT THE BILLINGS, MONTANA CITY CODE BE AMENDED BY REVISING SECTIONS 7-2024(2)(b), 7-2034(2)(b), 7-2043(2)(b), 7-2052(2)(b), 7-2058(2)(b), and 7-2063(2)(b) TO CHANGE THE MINIMUM AGE REQUIREMENT FOR EMPLOYEES OF MARIJUANA BUSINESSES

BE IT ORDAINED BY THE CITY COUNCIL OF THE CITY OF BILLINGS THAT:

Section 1. That Section 7-2024(2)(b) of the Billings, Montana City Code (BMCC) is amended so that such section shall read as follows:

Sec. 7-2024. Requirements to obtain and retain a medical marijuana dispensary license.

Section 2. That Section 7-2034(2)(b) of the BMCC is amended so that such section shall read as follows:

Sec. 7-2034. Requirements to obtain and retain a retail marijuana dispensary license.

- (2) Personal requirements for the licensee, principals, registered manager and employees.

- (b) The applicant, principals, registered manager and employees are all over the age of eighteen (18).

Section 3. That Section 7-2043(2)(b) of the BMCC is amended so that such section shall read as follows:

Sec. 7-2043. Requirements to obtain and retain a marijuana cultivator license.

Section 4. That Section 7-2052(2)(b) of the BMCC is amended so that such section shall read as follows:

Sec. 7-2052. Requirements to obtain and retain a marijuana transporter license.

Section 5. That Section 7-2058(2)(b) of the BMCC is amended so that such section shall read as follows:

Section 6. That Section 7-2063(2)(b) of the BMCC is amended so that such section shall read as follows:

Sec. 7-2063. Requirements to obtain and retain a marijuana testing laboratory license.

Section 7. EFFECTIVE DATE. This ordinance shall be effective thirty (30) days after second reading and final adoption as provided by law.

Section 8. REPEALER. All resolutions, ordinances, and sections of the City Code inconsistent herewith are hereby repealed.

Section 9. SEVERABILITY. If any provision of this ordinance or the application thereof to any person or circumstances is held invalid, such invalidity shall not affect the other provisions of this ordinance which may be given effect without the invalid provisions or application, and, to this end, the provisions of this ordinance are declared to be severable.
